## Arizona Care Network (ACN) Accountable Care Program Policy Provider Participation Requirements: Aligned Facility Privileges

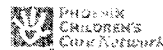
- I. PURPOSE:** To ensure ACN contracts with, and represents to covered patient populations, providers who are appropriately privileged to perform services in ACN care settings so that patient care can be optimally coordinated within the provider network and at the optimal benefit level.
- II. SCOPE:** This policy applies to existing providers and future provider applicants practicing in certain designated specialties (“Designated Specialties”) noted herein in Section VIII.
- III. EXCEPTION:** Existing providers and new provider applicants participating in certain designated specialties (“Exempt Specialties”) noted herein in Section IX.
- IV. DEFINITIONS:**
- A. Aligned Facility. An ACN contracted hospital or outpatient facility, such as those listed in Section VII. Aligned Facilities.
  - B. Qualifying Providers. Providers practicing in specialties listed in Section VIII. Designated Specialties.
- V. POLICY STATEMENT:** Qualifying Providers who admit patients and/or perform procedures in facility settings are required to have privileges at an Aligned Facility to participate in ACN.
- VI. POLICY IMPLEMENTATION:**

Existing *Qualifying Providers* (providers contracted with ACN at the time of Policy adoption)

- Qualifying Providers who lack privileges with at least one Aligned Facility must begin the process of obtaining privileges at an Aligned Facility by 7/15/2017.
- Aligned Facility medical staff rosters will be refreshed on a quarterly basis, and notices will be sent to Qualifying Providers who have not maintained privileges with an Aligned Facility, communicating that participation in ACN will terminate if privileges are not restored.

New *Qualifying Providers* (providers applying to participate as of the effective date of the Policy)

- Qualifying Providers who admit and/or perform procedures in facility settings must have provisional or active medical staff privileges (as verified by ACN) with an Aligned Facility prior to being eligible for formal review by the Network Committee.



ACN's Network Committee has flexibility to approve a Qualifying Provider who lacks provisional or active privileges for participation in the network based on the needs of ACN and/or a demonstrated ability to cost-effectively perform quality services in appropriate care settings.

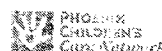
**VIII. DESIGNATED SPECIALTIES:**

Providers practicing in the following specialties shall have active provisional or privileges at an Aligned Facility if the provider performs procedures/admits patients in a facility setting:

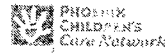
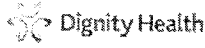
